## NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$0.164145 per \$100 valuation has been proposed by the governing body of ALVIN COMMUNITY COLLEGE DISTRICT.

PROPOSED TAX RATE \$0.164145 per \$100 NO-NEW-REVENUE TAX RATE \$0.164145 per \$100 VOTER-APPROVAL TAX RATE \$0.176602 per \$100

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for ALVIN COMMUNITY COLLEGE DISTRICT from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that ALVIN COMMUNITY COLLEGE DISTRICT may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that ALVIN COMMUNITY COLLEGE DISTRICT is not proposing to increase property taxes for the 2022 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 22, 2022 AT 6:00PM AT the Nolan Ryan Center at Alvin Community College, 3110 Mustang Road, Alvin, Texas 77511.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, ALVIN COMMUNITY COLLEGE DISTRICT is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of ALVIN COMMUNITY COLLEGE DISTRICT at their offices or by attending the public meeting mentioned above.
